

## MARCH 1, 2019 - MARCH 22, 2019 OFFICIAL CONTEST RULES

The "WESTGATE SUPERBOOK HOOPS CENTRAL SHOWDOWN" (hereinafter the "Contest") refers to the events occurring between Friday, March 1, 2019 at 9:00 a.m. and Friday, March 22, 2019 at 11:59 p.m. ("Contest Period") at the Westgate Las Vegas Resort & Casino ("Sponsor") located at 3000 Paradise Road, Las Vegas, Nevada 89109. All references to time of day contained herein refer to Las Vegas, Nevada Time.

- Must be at least 21 years of age to participate and participants must provide valid proof of age that is acceptable to Westgate
  Las Vegas Resort & Casino (driver's license, state identification card, or military identification card), which may act in its sole
  and absolute discretion as it deems appropriate. If Participant is not a U.S. citizen, a current passport or alien registration card is
  required.
- 2. All participants must have a valid Westgate Las Vegas Resort & Casino WOW rewards card. Westgate Las Vegas Resort & Casino WOW cards are free and are available at the WOW Rewards Center.
- 3. Contestants can enter the Westgate SuperBook Hoops Central Showdown by paying a two-hundred dollar (\$200) entry fee in person. Entry fees are non-refundable. Method of payment is cash.
- 4. Entry fees will be accepted for the Westgate SuperBook Hoops Central Showdown starting at 9:00 a.m. on Friday, March 1, 2019 and conclude at 10:00 p.m. on Wednesday, March 20, 2019.
- 5. Maximum of three (3) entries per person. Each entry shall be treated as a separate entry for all purposes.
- 6. The Westgate SuperBook Hoops Central Showdown will begin Thursday, March 21, 2019 and conclude Friday, March 22, 2019.
- 7. The Westgate SuperBook Hoops Central Showdown is based on selecting the game winner vs the contest lines on twenty-eight (28) first round games in the 2019 Men's NCAA Basketball Tournament played between Thursday, March 21, 2019 and Friday, March 22, 2019. Contest lines will be set by the Westgate Las Vegas SuperBook. Contest lines will not move once they are set. Contestants must select one side for each of the 28 first round games available. In the event a contestant has multiple entries, they may select one side on one entry and the opposite side on another entry. Contestants cannot use opposite sides in the same entry.
- Contest winners will be determined by the total number of points accumulated at the end of the first round of the 2019 Men's NCAA Basketball Tournament. Each winning selection will earn one (1) point. In the event a contestant has multiple entries, points do not combine.
- Contestants will be required to swipe their Westgate WOW Rewards Card at the Westgate Las Vegas SuperBook self-service contest window to make their selections. By signing the official entry form, the entrant becomes the "official contestant" and is the only one approved to collect prize money.
- 10. Contestants must submit their selections at the Westgate Las Vegas SuperBook by 10 p.m. on Wednesday, March 20, 2019. This deadline will be strictly enforced. Contestants who fail to submit their selections will be awarded zero (0) points for each team.
- 11. The selection ticket (receipt) generated by the Westgate Las Vegas SuperBook computer system is the official entry of record. The contestant's official selections will be those contained in the Westgate Las Vegas SuperBook computer system records. If a selection ticket is not produced via the self-service contest window the contestant must notify a Westgate Las Vegas Superbook supervisor immediately to receive a printed copy of their selections. The "selection sheet" itself is not an official entry of record.
- 12. Selections are only submitted once per contest entry per person. Contestants cannot void selections after the Westgate SuperBook business day they are submitted. All Westgate Las Vegas Hoops Central Showdown selection ticket void requests must be submitted to a Westgate Las Vegas SuperBook Supervisor for approval. In the event a contestant has multiple entries, a contestant must submit separate selections for each entry. If more than one (1) selection is erroneously accepted for an entry, the first selection associated with the entry will be the official selection of record.
- 13. Contest winners will be awarded 100% of all entry money collected less \$10 per entry administrative fee. PRIZE STRUCTURE: 1st Place 50% of prize pool, 2nd Place 30% of prize pool and 3rd Place 20% of prize pool. In the event of a tie, all entries will include a selection of the combined score of both teams in a designated game chosen by SuperBook Management. i.e. if you think the combined score of both teams will be 150, select 150. In the event a tie still exists, all prize money will be divided equally between all the contestants who remain tied.
- 14. All games must complete thirty-five (35) minutes of game time. In the event a game does not complete 35 full minutes of game time, both sides will receive zero (0) points for the purposes of the Westgate Las Vegas Hoops Central Showdown.
- 15. All Westgate Las Vegas SuperBook house rules apply to this contest unless otherwise stipulated by the rules.
- 16. The Westgate Las Vegas SuperBook reserves the right to cancel this contest or refuse to accept any registration or wager if the same could violate any federal, state, or country law, ordinance or regulation. Furthermore, the Westgate Las Vegas SuperBook may cancel the contest in the event of technical difficulties or other occurrences beyond the control of the Westgate SuperBook.
- 17. Selections may be accepted manually in case of a computer system failure or other unforeseen circumstances as deemed necessary by the Westgate Las Vegas SuperBook management.
- 18. Entry fees will not be refunded for any reasons other than the cancellation of the Westgate SuperBook Hoops Central Showdown.
- 19. NCAA.com and ESPN.com will be the official source used to post results. Games must be played by Saturday, March 23, 2019. In the event a scheduled contest game is not played by the end of the day Saturday, March 23, 2019, it will be eliminated from the contest and will not count for contest purposes.
- 20. After the winners are identified, a one (1) day verification period will occur. Any disputes with the contest and/or results must be provided to management in writing within this verification period. At the end of the 1 day verification period, the Westgate SuperBook Hoops Central Showdown results will be declared official. In the event of a dispute, the decision of management is final.
- 21. Management reserves all rights.

- 22. Prizes are non-transferable. All federal, state and local taxes and expenses related to the acceptance and use of the prizes are the sole responsibility of the winners. Prizes may be subject to reporting and withholding pursuant to federal IRS regulations, and participants are required to cooperate with Westgate Las Vegas Resort & Casino in completing necessary forms.
- 23. Employees as well as family and household members of Westgate Las Vegas Resort & Casino may not participate in any Westgate Las Vegas Resort & Casino Promotion unless otherwise allowed within the Company's Employee Handbook.
