WESTGATE RESORTS GLOSSARY

The purpose of the **Westgate Resorts Glossary** is to make content-specific words easily accessible to all external partners with its related definition. These are key terms and integral concepts when it comes to understanding all the business jargon and terminology associated with our Vacation Ownership product.



AFFILIATED RESORT

A timeshare resort that is part of a timeshare company's list of owned resorts.

ALL SEASON

Specific weeks within the Timeshare Calendar that may be considered as higher demand travel weeks that encompass weeks that are outside of Event Weeks.

ARRIVIA

Parent company of Westgate Cruise & Travel Collection.

BANKING

Timeshare owners can submit their contracted occupancy rights with an external exchange company for future use (up to 2 years). These companies, such as Interval International or RCI, allow the owner to stay at a different resort or to trade their timeshare week for another type of vacation activity (i.e. a cruise).

BORROWING

Timeshare owners can make a reservation in the current year by pre-paying their HOA Dues and Taxes which will allow them to use a week from their next occupancy year.





CLOSING COSTS AND FEES

Expenses paid by the buyer and/or seller at the time of closing (just like with any real estate transaction) and typically apply to deeded purchases.

CONVERSION FEE

When you convert your timeshare week for World of Westgate (WOW) Experience Points, this fee applies. You can then use these points to pay for all or part of a cruise through Westgate Cruise & Travel Collection.

DEED

The document used to convey an interest in real property, where title to the real property is transferred from one party to another.

DEVELOPER

The company that is responsible for the development and creation of the timeshare property. The developer generally owns the timeshare resort and is operated based on a timeshare plan.

DEVELOPER DEPOSIT

An owner can “deposit” their usage for the current year with Westgate Resorts to be used in a future year (up to 2 years). Fees apply when using the deposited week outside of their contracted usage rights.

DEVELOPER EXCHANGE FEE

A fee associated when Owners exchange their occupancy week or a portion of to be used at another Westgate destination. The Developer Exchange Fee is non-refundable and non-transferrable.

EXCHANGE COMPANY

A company that provides exchange services to timeshare owners under an exchange program. Timeshare Owners with a membership in good standing with these exchange companies are able to take advantage of the benefits offered in accordance with their Terms and Conditions. The two largest exchange companies are Interval International, Inc. (II) and Resort Condominiums International, Inc. (RCI).

EXCHANGE PROGRAM

The contractual arrangement between a developer and an association, or a timeshare owner's membership with an exchange company, which enables the timeshare owners at that resort to exchange the use of their timeshare for a similar vacation at another comparable resort.

EVENT WEEK OWNERSHIP (FIXED/FLOAT)

An Owner who purchased a specific event week that is guaranteed usage rights that follow the event within the usage year. The owner also has the option to move their event week (“float” their week) at their home resort and usage year at no additional cost, unless reserving in another event week within the same Timeshare Calendar. Owners can elect to float their week at least 30-days prior to their event week check-in date.

EVENT WEEK(S)

Weeks within the Timeshare Calendar that mark a specific holiday/event at specific Westgate destinations.

FIXED/FIXED WEEK OWNERSHIP

A Fixed Week is a specific week and unit during the calendar year, identified by a number (see Timeshare Calendar). Most fixed weeks begin on a Friday, Saturday, or Sunday. Ownership of a fixed week allows usage of the owner's villa for that specific week in that specific unit for as long as they own it.

FIXED/FLOAT WEEK OWNERSHIP

A Fixed/Float Week Ownership defines usage of a specific Week during the Owner's occupancy year but allows for floating of the unit within their unit type. Unlike a Fixed/Fixed Ownership, Owners are not guaranteed a specific unit each stay. Fixed/Float Week Owners also have the option to float their week at their home resort during the same usage year at no additional cost (unless reserving in a higher season) as long as it is at least 30-days prior to their Fixed Week check-in date.

FLOAT WEEK OWNERSHIP

A Float Week is not restricted by a calendar date but can be limited by a season. With float time, timeshare owners have a period of time (i.e.: their season) within which their contracted usage rights are available to them, on a first-come, first-served basis. Owners must make reservations for their desired week as it is not guaranteed until reserved.

GETAWAY WEEKS

Getaway Weeks allow owners to travel without relinquishing their vacation ownership week through valid external memberships (Interval International and Westgate Cruise and Travel Collection). Reservations can be made for a week up to 18 months in advance (for Interval International) on a first-come, first-served basis. Interval International and Westgate Cruise and Travel reserve the right to limit the amount of Getaway weeks an owner may use, and pricing varies based on size, season, and destination.

HOMEOWNER'S ASSOCIATION (HOA)

Parties responsible for operating, managing, and administering the project.

MAINTENANCE FEE & TAXES

A fee that timeshare owners are required to pay, at the beginning of each occupancy year, to cover the costs of running the resort. This includes daily management, upkeep, and improvements. Real property taxes are included in the HOA billing statement.

HOME RESORT

The Home Resort is the timeshare resort where a purchaser owns their timeshare. The home resort is used in determining the maintenance fee obligations and usage rights.

LATE FEES

Late fees are assessed anytime a payment is late for the HOA dues and taxes or mortgage.

LOCK-OFF VILLA (L/O)

A villa type with two or more bedrooms that can be used for one vacation period or allows an opportunity to split or "lock-off" the villa into two or more vacation periods by splitting or "locking off" portions of the villa. (Fee applies)

OWNER ACCOUNT MANAGEMENT ("OAM")

OAM website allows owners to manage their Westgate ownership online. They can make reservations, make mortgage and Maintenance fee payments, set up automatic payments, access WOW Loyalty benefits, support information, and update phone number(s), email, and mailing address. Visit www.WestgateOwners.com for more information.

OWNER REFERRAL PROGRAM

The Owner Referral Program is designed for owners to share discounted Westgate Vacations with family and friends further giving them the opportunity to also become Westgate



owners. Owners are compensated when their referrals purchase.

OWNER RENTAL

A reservation booked by an owner that falls outside of their ownership rights. Owners are eligible for discounted rates based on their Loyalty tier, based on availability. Owners can have 2 concurrent reservations. No annual limit.

PET POLICY FEE

A fee is charged when the owner brings up to 2 pets that are permitted per the Pet Policy. This fee is paid to the resort to cover the extra cleaning needed for the villa.

PRESIDENT'S LETTER

Personalized letter that contains details about the developments completed at each Westgate Resort property for the current year and the projects slated for the upcoming year.

PUBLIC OFFERING STATEMENT (POS)

Also known as Covenants, Conditions, and Restrictions (CCR) at some properties. This document details the rights and restrictions binding the owners of each resort unit-week. It specifies legally binding rules governing the use of the property. It is recorded in the Public Records of the jurisdiction where the resort is located and is approved by the local governing bodies. A copy of the document may be issued to the owners in CD-ROM or booklet form.

REBOOKING FEE

A fee is collected when an owner cancels their reservation and books a new reservation during their current usage year. This fee varies based on how far in advance the owner cancels their reservation and rebooks.

REINSTATEMENT FEE

A fee applies when an owner either fails to deposit or use their week within their current occupancy year, or a deposited week that isn't used within 2 years, or the owner's fixed week is a No Show. This fee allows the owner to receive a replacement week to cover the missed week. Other restrictions apply.

RESALE OWNERSHIP

A third-party transaction wherein the Developer is not a party to the purchase or sale of the timeshare. The Developer has severely limited various usage rights on these third-party transactions.





SEASON OF OWNERSHIP

The Timeshare Calendar is divided into Seasons that vary by Resort. Please refer to the Owner Guide to verify the weeks that fall within your season at your home resort.

SEASONAL UPGRADE FEE

This fee is charged when an owner wishes to book a reservation in a higher season than what they own. This is a one-time charge for the selected usage week for that occupancy year.

SECURITY DEPOSIT

A fee held by the property when the owner checks in to cover any incidentals (damages to the room, room charges, etc.). Once the owner checks out and the room is left in good standing, the fee will be released back onto the card or given back directly if paid in cash.

SKI SEASON

Weeks within the Timeshare Calendar specific to Westgate Park City Resort & Spa. This season typically runs mid-November through April.

SPLIT-WEEK

This allows Owners to request two reservations totaling the seven nights of ownership, one reservation for three nights and the other for four nights. A Housekeeping Fee is charged when a Float owner splits their week into this type of stay and the fee is charged on the second portion when booking the remaining nights.

SUPPLEMENTAL WEEK

This week is given at the time of purchase and usually to an owner whose first year of occupancy doesn't start in the current year. The owner will be required to pay a fee equivalent to the annual Maintenance Fee and Taxes for the resort and unit size they're requesting. This week is given a specific usage year to be used and cannot be banked with an external exchange company.

TIMESHARE

Allows buyers to purchase an increment of time, typically one week, in a condominium, villa, or apartment-type of furnished vacation accommodation (a.k.a. "unit"). Timeshare owners receive either a fixed or floating time reservation arrangement that may vary by unit type and season.

TRAVEL PARTNERS

The Travel Partner Program Is an upgrade from the standard Owner Referral program that allows owners to market Westgate vacations and potentially make even more money on their referrals as they are compensated when their referral books a vacation package and when their referral purchases Timeshare. Owners receive training on Westgate Vacation Package marketing and may obtain a Seller of Travel license through this program.



SKI SEASON

Weeks within the Timeshare Calendar specific to Westgate Park City Resort & Spa. This season typically runs mid-November through April.

UNIT UPGRADE FEE

This is a nightly fee that is charged when an owner chooses to book a larger unit size than what they are contracted. This is charged for the entire length of the reservation as owners cannot do partial upgrades. Fees vary based on size, location, season, and is based on availability.

USAGE YEAR

The year contracted for occupancy by the Owner. This can be Even years, Odd years, or Whole (Every Year).

WESTGATE CRUISE & TRAVEL COLLECTION ("WGCTC")

A full-service travel rewards program that provides exclusive access to members-only savings on travel.

WESTGATE MOBILE APP

A mobile application that allows owners and guests to navigate Westgate's resources. Within this application, the World of Westgate Loyalty program can be accessed to identify benefits, manage reservations, and for owners to utilize self-service access to their ownership account.

WESTGATE SPORTS AND ENTERTAINMENT

Westgate Sports and Entertainment is an internal marketing team that specializes in creating high-value customized experiential vacation getaways for Owners and guests.

WHOLE OWNERS

Owners that purchase all 52 weeks of the Timeshare calendar at the following locations: Westgate Park City Resort & Spa and Westgate Branson Woods Resort.

WORLD OF WESTGATE LOYALTY PROGRAM ("WOW")

The World of Westgate Loyalty Program rewards Members for choosing Westgate Resorts as their preferred destination for making vacation memories with family and friends.
